

any other required correspondence, directing any clerical staff, maintaining the society's records, recording minutes of Executive Committee meetings, maintaining inventory and distributing <u>and</u> (should read "any") publications of the society.

COMMENT: In addition to the underlined typo, the secretary no longer has the responsibility for maintenance of inventory or distribution of publications. Some years ago the society approved Section 6 of this constitution which established the position of Publication Chairperson. This position assumes the responsibility for all publication related matters.

Therefore, the proposed wording for the section in question (Article V, Section 3) is as follows:

Section 3. Secretary. The secretary shall be responsible for writing and sending out meeting announcements and any other required correspondence, directing any clerical staff, maintaining the society's records and recording minutes of Executive Committee meetings.

CHANGES TO BYLAWS

The proposed Bylaws change consists of the addition of a new Article dealing with the financial matters of the society. The additions will codify informal practices that have been followed by Executive Committees for years. Having these policies in the Bylaws makes the practices of the Executive Committee transparent to the membership and provides clear guidance to future generations of officers. We have made a strong effort to provide enough flexibility for future committees to be able to meet new challenges while insuring that the intent of our predecessors is clear to all. Note that in section three only the first three symposia are considered. This is because the accounting and review of the 2000 symposium is not yet complete. These funds will be the first to be handled under section three of these proposed changes.

The proposed article reads as follows:

Article V. Fiscal Policy and Financial Management

Section 1. The Executive Committee shall manage the business of the GSN in a fiscally responsible manner.

Section 2. It shall be the intent of the Executive Committee to follow, as closely as practicable, an annual budget where expenditures do not exceed operating income. The budget will be prepared annually by the Treasurer in consultation with the President and Vice-President and be approved by the Executive Committee. Section 3. The GSN shall establish and maintain an Investment Fund to ensure its ability to meet potential liabilities incurred through the organization of symposia or other large special events, to serve as a capital fund for future capital expenditures and to promote financial stability by providing additional operating income from investment earnings. The initial deposit shall consist of the funds set aside by resolutions of the trustees from the 1987, 1990 and 1995 symposia.

Section 4. The Executive Committee shall deposit no less than 50% of the profits from any large special event, such as a symposium or significant contribution, into the Investment Fund described in Section 3. The Executive Committee shall determine what events or contributions qualify on a case-by-case basis.

Section 5. The Executive Committee may apply earnings from the Investment Fund for a fiscal year to operating income for that year. The amount of earnings eligible for such conversion shall not exceed 50% of the earnings for the year in question.

Section 6. The principal balance of the Investment Fund may be used for any purpose deemed necessary by the Executive Committee and approved by a majority of returned ballots received by the officers ten (10) working days after a proposal by the Executive Committee for such use has been received by the membership.

Section 7. The Treasurer shall, at a time specified by the Executive Committee, make an annual report to the membership which will include: A summary of the income, expenditures and asset balances for the previous year; the approved budget for the upcoming year; the status of the investment fund.

MINERAL DEPOSITS AND EXPLORATION IN MALI

Dr. Greg Arehart, Professor, Geologic Sciences, University of Nevada, Reno

Mali has a long and rich history of gold mining. Although most of the historical production is from placers and paleoplacers, several primary gold sources have been discovered and exploited in recent years. These include mesothermal gold systems such as Syama and Kalana, and the "Carlin-type?" system at Sadiola. An overview of the geology of Mali and exploration for mineral resources in the southern part of the country will be presented, along with some cultural photos of the country.

The bedrock geology of southernmost Mali is dominated by the Birimian craton (2.2 Ga), which comprises greenstone belt rocks with interspersed granitoids. Western Mali comprises late Precambrian sedimentary packages, and northeastern Mali is made up of Paleozoic basinal rocks accreted to the Birimian craton, or recent cover (desert sands). Much of Mali has been deeply weathered, the relief is very low and is covered by lateritic soils at present. Because there has been little movement of the African craton, these laterites are among some of the oldest in the world, dating back as far as the Paleocene. Historical (traditional) mineral production has come from placers in the Niger river and its tributaries, and includes primarily gold but also some diamonds. In addition, small local operations (by today's scale) are exploiting pale-oplacers underlying the laterites. In the past couple of decades, there has been increased exploration for and development of the bedrock resources, although exploration for these resources can be very difficult in areas of extensive laterite development.



In Memory of Henry Herbert Shear

GSN and the geologic community have lost a real gentleman. Henry Herbert "Herb" Shear died suddenly on January 6, 2002 while visiting family in Seattle, Washington. Herb was born in Missouri in 1935 and grew up in south Texas. He graduated from University of Arizona in 1960 with degrees in geologic engineering and mining engineering. Most of his career was spent in British Columbia where he became a Canadian citizen. His work was primarily as an independent prospector, but he also operated two mines. Herb founded and was President of Dentonia Resources and Skylark Resources, among other companies. In recent years, he returned to Nevada and reclaimed his U.S. citizenship. He lived in Tonopah and owned mining properties in the Tonopah area and in Mexico.

Herb Shear was a strong supporter of GSN and attended numerous field trips, symposia, and meetings. His friendliness, straightforwardness, and honesty will be sorely missed.
